(hereinafter referred to as the Licensor) on the one hand and the Deputy Editor-in-Chief of the scientific journal «Studies in history and philosophy of science and technology» KUSHLAKOVA Nadiia (hereinafter referred to as the Licensee), on the other hand, entered into this agreement as follows:

**1. SUBJECT OF THE AGREEMENT**

The Licensor grants the Licensee a non-exclusive license to use a written work (scientific, technical or other) free of charge:

**2. PROPERTY RIGHTS TRANSFERRED TO THE LICENSEE**

2.1. The Licensor grants the Licensee the right to use the Work in the following ways:

2.1.1. To use the Work by publishing it in the scientific journal «Studies in history and philosophy of science and technology» (hereinafter - the Edition) in the original language.

2.1.2. To use the Work by translating and publishing it in the scientific journal «Studies in history and philosophy of science and technology» (hereinafter - the Edition) in English.

2.1.3. To rework, adapt or otherwise modify the Work in agreement with the Licensor.

2.1.4. To publish the Work in whole or in part on the website of the journal "Studies in history and philosophy of science and technology" and on the Internet resources of scientific libraries, which present the journals "Studies in history and philosophy of science and technology".

2.2. If the Licensee wishes to use the Work in other ways, in particular, to translate the work in other cases than those specified in paragraph 2.1 of this Agreement, to publish the Work in other publications, including foreign, such use is made in an appendix to this Agreement.

**3. TERRITORY**

3.1. The Licensor grants the Licensee the right to use the Work in the ways specified in p. 2.1.1–2.1.4 of this Agreement, on the territory of Ukraine, as well as the right to distribute the Work in Publication in printed and electronic form on the territory of Ukraine and abroad by means of subscription, sale and free transfer of the Publication.

**4. TERM FOR WHICH THE RIGHTS ARE GRANTED**

4.1. This Agreement is concluded after the Licensee accepts the Work for publication. The contract is valid from the date of its signing and is concluded for a period of 10 years.

4.2. Upon expiration of this Agreement in the absence of written statements of termination from the Licensor and / or Licensee, the term of this Agreement is automatically extended for another 10 years, but not later than the expiration of the exclusive property right to the Work.

## 5. CAUTION

5.1. The Licensor states:

- that he/she is the author (co-author) of the Work,
- if the Work was created in connection with the performance of an employment contract, the Licensor has the right to grant permission to use the Work under this Agreement,
- When creating the Work, the Licensor does not violate the intellectual property rights of others. If the Work contains materials of other persons, except for citations in the amount justified by the scientific, informational or critical nature of the Work, the use of such materials is carried out by the Licensor in compliance with copyright.
